12. First Information contents (प्रथम सूचना तथ्य):

इस समय उप पुलिस अधीक्षक संतोष कुमार शर्मा ने एक दरखास्त मय जांच रिपोर्ट शिकायत सं0 87/SR/2019 दिनांक 22.11.2019 व फाईलों के बराबरे कायमी मुकदमा पेश की जिसका मजबूत जैल है। MHCPolice Station State Vigilance Anti-Corruption Bureau,Solan, District Solan Himachal Pradesh.Complaint No. 87/SR/19 was received from the office of the Superintendent of Police, State Vigilance Anti-Corruption Bureau (SR) vide office letter No. SVACB(R-SR) Comp. (SLN) 87/SR/19-6352 dated 22-11-2019 for verification. It was alleged by the complainant Sh. Dinesh Kumar S/o Jagat Ram, Village Gharsi, Tehsil Kasauli, District Solan that Sh. Uma Dutt was appointed as incharge Fair Price Shop (FPS) Gharsi in June, 2016 by Pradhan Gram Panchyat, Gharsi, Inder Sen thereafter by D.F.C., Soaln in October, 2016 and that Uma Dutt, Depot Holder of FPS, Gharsi has taken rations on 53 fake ration cards from July 2016 to June 2018 and had also made false entries in the stock register, sale register and diverted the food grains/ration from one head to other. It was also alleged that Uma Dutt also black marketed the civil supplies rations. It was further alleged that on 06-11-2018 District Controller Civil Supplies and Consumer affairs, Solan, had ordered Inspector Food Civil Supplies Consumer Affair, Dharmapur, District Solan to make an enquiry and submit report within a week, Sh. Uma Dutt lodged a complaint with police post, Kunihar on 26.11.2018 stating that the record pertaining to Depot Gharsi has been lost by him. During enquiry, records were procured from Food Civil Supply Department and as per the report submitted by Sh. Girish Nesta Sh. Dharmesh Sharma both Inspectors food Civil Supplies Consumer Affair the following irregularities were found in FPS Gharsi during the tenure of Uma Dutt:-1. The false information was submitted to the Department by the depot holder regarding monthly feedback for the month of June 2016, September 2016, February 2017 and December 2017 and January 2018 to October 2018. 2. The false information was submitted to the Department by the depot holder with regard to the Sugar of Antodaya for the month of June and July 2018.3. APL Rice of 700 kg. for the month of August 2017, 300 kg Rice of BPL for the month of September 2017 and 200 Kg rice of NFSA have been misappropriated by the depot holder as the entry of above mentioned ration was neither made in the column of receipt nor in the column of sale of the concerned register.4. Besides 10 Kg Atta and 50 Kg rice was also found misappropriated by the depot holder as false entries found in the concerned register.During enquiry by the Bureau it came to notice that Depot holder Uma Dutt diverted the PDS items like rice, sugar and wheat flour to other heads as the same are not reflected in the stock register. The penalty has been imposed on Depot Holder Uma Dutt under the provision of HP Essential Commodities (Distribution) orders 2019 by DFSC Solan. As such it has been established on record that Uma Dutt has wrongly diverted the ration items and when District Controller Food Civil Supplies Consumer Affair, Solan, initiated an enquiry against him, he lodged the complaint of missing the record in P.P. Kunihar, District Solan. It is quite possible that records have been shown as lost by the depot holder to frustrate the enquiry initiated by the Department. Also, it has been established that Uma Dutt has wrongly diverted the ration items and thus committed an offence under section 31 of HP PSCP Act. 1983 201 IPC. The approval of VHQ for the registration of a criminal case into the matter has been received vide letter No. SV ACB(R/SR-HQ) Comp.(SLN)87/SR/2019-14714 dated 31.08.2020. Hence, criminal case may be registered against Depot Holder Uma Dutt. Sd/-Santosh Kumar Sharma (HPS) Dy. Superintendent of Police, State Vigilance Anti Corruption Bureau, Solan, Distt.
